NORTHERN INDIANA When a family member or loved one requires skilled care after an inpatient hospital stay, it is important to know all of your options so that an educated and informed decision can be made. As your healthcare partner, a Franciscan Health team member is available to assist you and your family in making decisions about service providers that are appropriate for your next level of care.

There are some steps you or your caregivers can take as well. Take time to visit facilities and ask questions to learn everything it has to offer. When visiting the facilities verify all information you were told over the phone and trust your instinct. First impressions matter.

- What types of care do they offer?
- Is the facility certified by Medicaid and Medicare?
- What is the Medicare Overall Rating of the facility?
- What is the Medicare readmission rate?

Use the information from site visits along with the quality of care information from **Medicare.gov** to help you compare the facilities you're interested in.

Franciscan ACO cannot choose which patients are attributed to this program. However, you are more likely to be included if your primary care provider is in the ACO and you are enrolled in Medicare parts A and B.

Q: Why should I choose a Post-Acute Care Continuing Care Network (PAC-CCN) facility or agency for after-hospital care?

A: We recognize and respect patient choice. If you require care after a hospital stay, you can choose any facility or agency you wish. Patients and their families often look to us to provide information regarding options we believe are in their best interest. We work closely with the facilities and agenices in the PAC-CCN. These facilities and agencies are dedicated to the same goals we are: better quality care, reduced cost and higher patient satisfaction.

Q: What criteria were used to evaluate the PAC-CCN participating facilities and agencies?

A: Participants were chosen after a rigorous review process that considered their historical quality performance results. Participating facilities and agencies are required to demonstrate ongoing quality and performance through regular reporting to our ACO.

Q: What is the Medicare Overall Rating and why is it important?

A: A rating of 1 to 5 stars is the combined overall rating based on the health inspection, staffing and quality measures as reported by Medicare. The more stars the better. This rating is important because it gives you an accurate "snap shot" of the care provided by individual skilled nursing facilities and can help you decide which facility best fits your needs for care.

Q: What other information about a facility reported by Medicare is important to assess?

A: Skilled nursing facilities help residents recuperate after a hospital stay and avoid going back to the hospital. Sometimes it's necessary for a patient to return to the hospital. However, if a skilled nursing facility sends many patients back to the hospital, it may indicate the facility isn't properly assessing or taking care of its patients. The lower the readmission percentage rates, the better.

Q. How long will Medicare, Medigap or Medicare Advantage plan pay for a stay in a skilled nursing facility?

A: The number of days covered by your plan depends on how long your medical needs require skilled nursing care. Check with your specific plan regarding coverage and speak with the staff of the skilled nursing facility.

We encourage you to use this information when selecting post-acute care. This information can help you compare skilled nursing facilities by important topics and help you think of questions to ask when you visit the skilled nursing facilities.
